STANDING COMMISSION & COMMITTEE REPORTS

Americanism Commission

Chairman Borgman stated Butch Ray attended 2015 Combined Americanism Conference held in Indianapolis Sept 25-27. A "Chaplains Manual" was discussed and one was submitted for review. There has been no change in Flag Alliance. Oratorical is coming up in March. Now is the time to recruit candidates for this, along with Boys State in June. National Emergency Fund (NEF) is the prime objective of our National Commander. The funds are available to every member of the American Legion Family and please consider donating to this. Motion by 8th District Commander Hunter to accept report, with the second, passed.

Children & Youth Commission

Chairman Ray discussed Temporary Financial Assistance (TFA) which is a program to help meet basic needs (shelter, food, utilities & medical) of veteran's children when parents are unable to do so. Youth Suicide Prevention was discussed and third leading cause of death among adolescents. CWF awarded \$640,395 in grants to 24 non-profit organizations including Kids In Danger of Chicago (\$15,000), National Children's Cancer Society of St Louis (\$21,000) and ThinkFirst of Naperville (\$21,100). SAL National Commander's CWF Goal is \$400,000. Motion by 9th District Commander Gort to accept the report, with the second, passed.

National Security & Poppy's

Chairman Phelps discussed Police School in June. A total of 83,086 troops have been unaccounted for as of August 12, 2015. Poppies typically start up around March and continue through May. Please help with the program. Nothing much has changed with National Security since the Fall DEC report. Motion by 8th District Commander Hunter to accept the report, with the second, passed.

Legislative Commission

Chairman Griffin reported the following legislation was discussed: HR 1338 – Dignified Internment of our Veterans Act of 2015 – Requires the Dept. Of Veterans Affairs to conduct a study and report back to Congress on the problem of unclaimed remains of deceased veterans and also places a \$2 million cap on Fiscal Year 2016 bonuses for VA senior executives. HR 1384 – This bill honors Veterans, retired National Guard and Reserve personnel who have served 20 years and do not meet the full requirements for Veteran status under Title 38, United States Code. Both bills await consideration by the Senate. Statistics from the Vietnam War were shared reminding us of the huge sacrifice made by those who served during that war. Motion by
