**RULES COMMITTEE REPORT**

Chairman Jarosz presented the rules of the Convention. He stated there were changes that were approved at the 49<sup>th</sup> Convention. Rules 18, 25, 27 & 28 were revised. The Committee recommends the changes from the 49<sup>th</sup> Convention to be revised at the 50<sup>th</sup> Detachment Convention Rules.

**Rule 18** should state: All nomination and seconding speeches are limited to only members of The Sons of The American Legion who are official delegates of the Sons of The American Legion Detachment Convention with appropriate Sons of The American Legion cap and Detachment Convention delegate badge.

**Rule 25** should state: There shall be no food or alcoholic beverages on the Convention floor during Convention Sessions.

**Rule 27** should state: Appropriate attire will be required of all Detachment Officers and members of the Detachment who will be addressing the Convention from the podium. Appropriate attire for the above mentioned will consist of: dress slacks, collared shirt, jacket, tie, and Sons of The American Legion cap.

**Rule 28** should state: Any member of the Detachment who will be approaching the podium for the purpose of making a donation, accepting an award or any other purposes shall wear appropriate attire consisting of: dress slacks, collared shirt, jacket, tie, and Sons of The American Legion cap.

He then discussed all the areas Americanism covers within our Legion Family. Cisna gave a brief update on Flag Alliance, stating nothing has really changed with current bills. Borgman motioned to accept his report, with the second, passed.

**CHILDREN & YOUTH COMMITTEE REPORT**

Chairman Ray reported that CWF donations were \$30,427.13, a \$2 per capita based on membership which is 4<sup>th</sup> in the Nation. Shipley presented CWF awards to Garrett, Cisna, Ray, Hunter, Melone, Hudson, Gierach and himself. Ray then stated Scholarship winners will be announced on Sunday. Ray motioned to accept his report, with the second, passed.

**FINANCE REPORT**

Finance Officer Tharp asked if there were any questions regarding the printed balance sheet or budget for 2013-14. None were asked. Finance Chairman Cisna then approached. Stated there was a request presented to the Finance Commission for the Detachment to give \$750 to both JR Stillwell and Jimmy Hunter to attend The First Annual Sons of The American Legion Hall of Fame Gala Awards and Banquet in Pasadena, CA on November 2, 2013. PNC Stillwell will be inducted into the Hall of Fame and Hunter will attend as a representative of Illinois. Commander Hunter asked Commission to reimburse \$377.31 in expenses that went over his budget. Stated PDC Williamson mentioned Jr. Auxiliary member Kristy Krigbaun will be attending National Convention in hopes of being appointed National Jr. Auxiliary President and looking for donations to help cover expenses. The "hat" was passed. Cisna motioned to accept entire Finance Report, including the dollar amount requests, with the second, passed.

**LEGISLATIVE COMMITTEE REPORT**

Chairman Jarosz gave report. Stated Dual Member Sylvester Hendricks asked for a Resolution that all meetings above Squadron level be held in handicap accessible Legion Halls/centers. Was discussed in length and tabled for Fall DEC to discuss and report. Reported Senate Immigration Reform Bill S744 was introduced this past week and Legion Legislative staff was reviewing its contents. Economic Division is reviewing in-state tuition legislation sponsored by Veterans Affairs Chairman Sanders (VT) and Ranking member Burr (NC). The Legion submitted testimony on this legislation on June 5<sup>th</sup>. President Obama signed into Public Law PL113-12 the Stolen Valor Act of 2013 where it makes it a crime to knowingly benefit from false statements about receiving certain military awards and decorations. Jarosz motioned to accept his report, with the second, passed. Then Jarosz asked Commander Hunter for a point of personal privilege and thanked everyone for the opportunity and honor to work all of our members.

**NATIONAL SECURITY COMMITTEE REPORT**

Chairman Phelps discussed cuts in the military and attitudes of American's as freedoms are slowly seem to be disappearing. He discussed illegal immigration and how the country seems to bow down to the wants and requests of illegal immigrants. Discussed POW/MIA and process involved of identifying the remains and the fact that there are still many missing. Asked everyone to promote Police School next summer, along with helping out with Poppy Distribution. Phelps motioned to accept his report, with the second, passed.

Help Hospital Veterans is looking for arts and crafts kits, along with woodworking kits for bird houses, jewelry boxes, etc. Gifts To Yanks Report will be given on Sunday. Williamson motioned to accept the report, with the second, passed.
