**COMMISSION & COMMITTEE REPORTS**

**Americanism:** Chairman Borgman reported that the Detachment consider instituting a Chairman for Boys State on the Squadron, District and Division levels, like Department of Illinois. Currently they are barely getting 500 boys to participate. Sen. Orrin Hatch, R-UT, Senate Joint Resolution 17 proposing an amendment to Constitution that would give Congress authority to protect flag from physical desecration. Encouraged contacting Senators and Representatives on Flag issues. Religious Emphasis at the opening and closing of DEC's there will be words of scripture for inspiration. Borgman still on National Americanism Commission. Jr shooting National Championships held Aug 23<sup>rd</sup> in Colorado. 8<sup>th</sup> District's Borgman motioned to accept report, with the second, passed.

**Children & Youth:** PDC Ray reported that there is \$1,539.90 remaining in Josh Dog fund and Commission voted and approved to use funds to purchase more dogs to be split between Illinois Children's Hospitals. Commission also approved to send \$1,000 to Toby Tire program. Detachment received thank you cards and letters from all three IL CMN hospitals for donations this past year. Also received 10 letters from scholarship winners from Convention. Commission congratulates IPDC Jimmy Hunter on his year with CWF, raising \$30,427 during his year. The Detachment won the per capita award for Central Region on National level. Hunter thanked everyone for all their help. Goal for this year is \$1 more. Eugene Gort is new CWF promoter. National Commander Joe Gladden's goal is to pass \$6 million and raise \$500,000 for the year. Banner program is available and forms are available today and will be in bulk mailing. Discussed CAT program. NEC Williamson motioned to accept the report as given and there was a second. PDC Melone asked about a letter that supposedly PDC Stratton received and Commander Cavanaugh stated it was in hands of Department Internal Affairs. Melone asked if Commander has copy of letter, which he said yes. Adjutant stated he never received a copy of letter. PDC Ray stated Stratton did a fantastic job raising funds and it will be difficult to do what he has done in the past, but we will all work hard on it. The motion passed.

Commander Cavanaugh turned podium over to Sr Vice Jarosz at 1426. Sr Vice called upon Contest Committee for report.

**Contest:** Chairman Pillman stated Committee discussed Convention Scrapbook mishap at Convention. Committee wants Adjutant to include the rules and regulations in bulking mailing. Pillman motioned to accept his report, with the second, passed.

**Finance Commission:** Chairman Cisna discussed Finance Commission/Finance Officer Guideline book and changes to be made to be done. Approved Finance Officer \$500 to upgrade his QuickBooks. Overage funds of 36% to CWF, CMN, Toby Tire, Special Olympics, NEF & GTTY (each to get 6%). \$4,959.46 remains for the year for donations. It was recommended by Bill Geary that we round each amount to \$1,000. PDC Melone asked what the invoice from Department was and if itemized. Finance Officer stated yes and it was \$3,354.03. This amount is over the \$5,700 what Department budgets for the SAL. 1<sup>st</sup> Division's Pillman motions to accept report, with the second, Geary clarifies that by approving this report we are making the 6 donations \$1,000 even, passed.

**National Security & Poppy Commission:** Chairman Phelps discussed Syria and immigration problems. Also discussed how the government is going into people's banking accounts to tracking their spending, along with emails and phone calls. Stated now is the time to start recruiting participants for shooting sports and police school. Stressed the importance of Poppy Program and alluded to a problem at Hines Medical Center. Stated he will report on this later. 10<sup>th</sup> District's Koop motioned to accept report, with the second, passed.

**Legislative Commission:** Chairman Griffin reported discussion on Immigration Bill and how National Legion feels blanket amnesty would send message that America's Immigration Laws are to be scoffed at. HB 2563 allows members of military to bypass state skills test in applying for CDL license. HB 3186 recognizes members of military who have training and clinical experience when applying to be EMT. SB 204 makes college degree requirement exemptions for certain members of military applying for Illinois State Police positions. Discussed SAL Homeland Security & Civil Preparedness Committee's "be ready, be informed, be prepared" motto and website ready.gov/America. 10<sup>th</sup> District's Koop motioned to approve, with the second, passed.

Sr Vice Commander Jarosz turned podium back over to Commander Cavanaugh at 1452.

**Leadership & Training:** Commander Cavanaugh reported his new Squadron Training Program. Training will be designed to show the Squadron Officers what their duties entail and how to handle various problems. 10<sup>th</sup> District's Koop motioned to accept, with the second, passed.

**VA&R:** Discussed the Reps & Deps for VA Hospitals and Homes and looking for a few more. From National Post Convention NEC, Commander Gladden's VA&R Projects are Fisher House & Missing In America Project. Discussed Dunham Sports in Danville who didn't want to hire vets for employees. Maryland Squadron 77 received Squadron of the Year for VA&R and Detachment of GA Detachment of the Year for VA&R. 30% Consolidated Squadron Report Forms on National level, 105 from IL. Squadron 287 in IL was 17<sup>th</sup> in Nation. Williamson motioned to accept his report, with the second; Stillwell mentioned National will only accept a Squadron report or Detachment report. District and Division reports are not accepted on National level, motion passed. Williamson then gave his NEC report (details later in the minutes).

**Public Relations:** Vice Chairman Cisna reported on Snapshots of Service contest from Aug 1 to 30 days prior to National Convention. Also National is looking for pictures for new SAL handbook. Bulk mailing needs to be submitted to Detachment Adjutant by the 15<sup>th</sup> of each month. Publications Chairman/Asst Adjutant Ray discussed Detachment directory and getting in the information. Ray also discussed Convention ad book contracts will be in every bulk mailings and would like them have in by 15<sup>th</sup> of December. Cisna then talked about National Legion & SAL Commander and National Auxiliary President in DEC reporting to Congress. Motion by 10<sup>th</sup> District's Koop to accept report, with the second, PDC Melone asked why we have a Publications Editor since the Asst Adjutant is handling publications and it was stated that there really isn't one anymore, the motion passed.
