The Executive Committee of the Detachment of Illinois, Sons of The American Legion, will meet at 1:00 P.M. on Saturday, December 5, 2020, at the American Legion Department of Illinois Headquarters, 2720 East Lincoln Street, Bloomington, IL 61704. We will hold our meeting in the downstairs conference room.

As a regular meeting of the Executive Committee any Detachment business may be considered. Due to the State mandated Covid-19 policy, only voting DEC members, Committee/Commission Chairmen and Detachment Officer's will be allowed in the meeting room. Guests will not be permitted on-site. Social distancing will be practiced during the meeting. This meeting will be broadcasted live via Zoom for any Legion family members to attend virtually. Questions/comments via Zoom will be monitored by the Detachment Adjutant & Asst Adjutants. **Zoom information will be sent out to those who wish to attend virtually and RSVP by December 2, 2020 to the Detachment Adjutant.**

Commission and Committee Chairmen will schedule their meetings to be virtual via Zoom and have meetings complete BEFORE the DEC. Chairmen should be scheduling their Zoom meetings with their members and notify the Detachment Commander and Detachment Adjutant when these meetings will take place. All Commission and Committee reports are to be turned in to the Detachment Adjutant by December 2, 2020.

Voting DEC members, Detachment Officer's and Committee/Commission Chairmen who plan on attending this DEC must notify the Detachment Adjutant by December 2, 2020. **If you wish to participate via Zoom (voting or non-voting member), you still need to contact the Adjutant for Zoom login information.** This is very important. You will not be permitted into the building if you did not RSVP to the Detachment Adjutant. Zoom information will only be sent to those who also RSVP to the Detachment Adjutant. **The cutoff for RSVP's is December 2, 2020.**

All printed materials for the meeting will be emailed out ahead of the meeting with the Zoom login information. The Zoom login information will not be posted online.
